Summary: The Medical Director of Behavioral Health (Psychiatrist) is responsible for providing coordinated psychiatric services to patients utilizing the clinical services of Family Health Center. Clinical services provided shall include routine and crisis adult and pediatric care as assigned. The scope of practice includes evaluation, diagnosis, medication assessments and adjustment, patient education, and treatment planning. The psychiatrist will be knowledgeable about agency and clinical policies, keep all patient information confidential, and shall assume responsibility for the development and realization of an individual ongoing care plan for all patients. As Medical Director for the BH Department, is medically responsible for the delivery of health care for the BH Dept., including direct oversight of the medication management providers. Works closely with the BH Leadership team to reach department and organizational goals.

Approximately 8-hours per-week or 20% of time the medical Director's Primary administrative responsibilities encompass supervising, evaluating and managing performance of providers. The Medical Director collaboratively will assist the Chief Behavioral Health Officer and Chief Medical Officer in recruitment and retention of providers, maintains productivity standards, financial and clinical accountability, assists in the development and implementation of policies, procedures and special projects.

- Documented **completion of a residency** from an accredited institution in an appropriate specialty
- **State of Connecticut Physician License**, valid federal & state controlled substance licenses
- **Board Certification required** or **board eligible** in adult and child psychiatry
